


Several current and former Albertus students collaborated with members of the psychology faculty on research projects that led to presentations at the Association for Psychological Science's annual convention last summer.

Kimberly Breed '07 was co-author with Dr. Stephen Joy, of "Personality, divergent thinking, and creative performance in a story-writing task." Kathleen Sullivan, currently a senior in the Accelerated Degree Program, co-authored "Ecstasy and memory: Meta-analyzing the cognitive correlates of MDMA use," also with Dr. Joy.

Renee Bacon '04, Nicole Kras '01 and now enrolled in the Master of Arts in Art Therapy program, and Kelly LeBlanc '05 and now enrolled in the Master of Arts in Art Therapy program, co-authored "Thematic Apperception Test correlation with Speicher trait intimacy capability and intimacy motivation" with Dr. Hilda Speicher.

Breed, Sullivan and Kras travelled to Washington, D.C., for the conference, attending talks by some of the nation's leading psychological researchers, in addition to making their own presentations.

College Celebrates Constitution Day with Lecture and Art

As part of the College's celebration of Constitution Day, Joan Channick, managing director of New Haven's nationally-acclaimed Long Wharf Theatre, spoke to a gathering of alumni and members of the Albertus community in Rosary Hall on September 10. Her topic: the impact of the constitutional protections of free speech on the arts. Channick graduated from Harvard University, holds a J.D. from the University of Pennsylvania School of Law and an M.F.A. in theatre administration from the Yale School of Drama, where she teaches a course on law

Channick's talk complemented the opening of an exhibition of postcard-size artworks that explored the impact of the U.S. Constitution and the Bill of Rights on the lives of people living in the United States today. Alumni, students and the public submitted nearly 100 works; entries came from Japan and Canada, and many states, including Nevada, Michigan, New Mexico and Georgia, as well as Connecticut and other New England states.





On November 14 in the Behan Community Room of the Hubert Campus Center, Roxanne J. Coady, president and founder of R. J. Julia Booksellers in Madison, Connecticut, inaugurated the Tagliatela School of Business and Leadship's 2007-2008 Regional Speaker Series. Introduced by President Julia M. McNamara to an audience of nearly 200 students, faculty, staff and alumni, Coady spoke of her circuitous career path from tax accountant for a major corporation to bookseller; R. J. Julia is considered one of the top independent booksellers in the country. Her advice to students, whether in traditional or adult programs, was to always be willing to do whatever it takes to get a job done, to be flexible and, above all, to be open to whatever opportunities come along. She also encouraged them to give

back to their communities by getting involved with not-for-profit organizations. The next speaker will be David R. Fusco, president, **Anthem Blue Cross and Blue Shield in Connecticut, on January** 25, followed by Jeffrey P. Pino, president, Sikorsky Aircraft Company, on March 7; John Baldoni, author and consultant on leadership, will be the speaker for the National Speaker Series on **April 11. The remaining programs** take place at 5:30 p.m. in the **Atrium of the Academic Center** for Science, Art and Technology, followed by a reception.




Reception Marks Milestone for Graduate Art Therapy Program

The College's Master of Arts in Art Therapy—the only graduate degree program of its kind in Connecticut—is observing its 10th anniversary. Sixty-four students have graduated from the program, and 55 presently are enrolled. Alumni work in hospitals, clinics, homes for the elderly, hospices and out-patient programs. Current students, alumni, faculty and staff gathered in the St. Albert Atrium of the Academic Center for Science, Art and Technology November 2 to mark the milestone. Sr. Eileen Gannon, O.P., a member of the Sparkill, New York, Dominican congregation, spoke in November to a noontime audience of the Albertus community about her work as the United Nations representative of the Dominican Order in the United States. Serving at the UN for the past 10 years, she represents members of the Order who are in more than 100 countries around the world, and works with other Non-Governmental Organizations (NGOs) to share information, lobby and influence the growing number of people who work for change in the world through the UN. Her challenge to students: always be open to another point of view.

The College is among the 600 private colleges and universities participating in a new, Web-based initiative that provides prospective students and their parents free and accurate comparative data to help them make a decision on which college to apply to or attend. The National Association of Independent Colleges and Universities coordinated the U-CAN (University and College Accountability Network) project. - Dr. Susan Cole, professor of English and director of the concentration in creative writing, read from and signed copies of her latest book, "Missing Alice: In Search of a Mother's Voice," on November 8 at R.J. Julia Booksellers in Madison. Connecticut.
- Julia Coash, associate professor of visual and performing arts and co-chair of the department of visual and performing arts, took part in "Painters' Projects," a month-long exhibition of new paintings and related projects by three artists in the Seton Gallery at the University of New Haven in the fall. Galleries representing Coash's work include Grey McGear Modern in Los Angeles and the Townhouse Gallery in Cairo. She has an M.F.A. from James Madison University and an M.S. Ed. in higher education from Southern Illinois University.
- Dr. Stephen Joy, associate professor of psychology and chair of the psychology department, was sole author of an article published in the December 2006 issue of Perspectives on Psychological Science, an official of the Association for Psychological Science. The article, a study of publication activity in a sample of more than 1,200 academic psychologists, is titled "What should I be doing, and where are they doing it? Scholarly productivity of psychology faculty."
- On October 12, Francesco C. Cesareo, Ph.D., became the 16th president of Assumption College in Worcester, Massachusetts. Dr. Cesareo, who specializes in the Renaissance and Reformation periods, taught history at Albertus Magnus in the late 1980s. His wife, Filomena Pascarella Cesareo, graduated from Albertus in 1986 and the University of Bridgeport Law School (now Quinnipiac University School of Law) in 1989.
- Suzanne Yurko Wall, director of career services, has been elected to her second two-year term as secretary of the Connecticut Career Counseling and Development Association.
- Paintings by adjunct faculty member Anne
 Hebebrand were on view at the Chase/Freedman
 Gallery of the Mandell Jewish Community Center
 in West Hartford, Connecticut, for two months this
 fall. Originally from Germany, she received the
 B.F.A. degree in painting and drawing from the
 Boston Museum School and M.A. in art history
 from the University of Birmingham. Hebebrand
 also is a member of the adjunct faculty at
 Manchester Community College and a teaching
 artist for the Bushnell PARTNERS program, the
 Wadsworth Atheneum Museum of Art and the
 Connecticut Commission on Culture and Tourism.
